## **UAE: New Plant Varieties Law 8 of 2025**

UAE government introduced the new Law 8 of 2025 on the Protection of New Plant Varieties protects breeders' rights, promotes agricultural innovation, and enhances food and biosecurity. It replaces Federal Law No. 17 of 2009 and aligns national legislation with international standards set by the International Union for the Protection of New Varieties of Plants (UPOV).

The European Patent Office (EPO) announced that it has officially discontinued the traditional Online Filing (eOLF) desktop software and adopted Online Filing 2.0 as its standard filing tool. As of 1 January 2026, all patent applications and related submissions must be filed exclusively through this web-based system.

## Morocco - Growth in Patent Filings in 2025

Patent activity in Morocco experienced significant growth in 2025, with 2,414 applications submitted, including 338 from local innovators—a 39% rise compared to 2024. Universities led the way, contributing 64% of domestic filings, followed by individual inventors (20%) and businesses (13%).
